Construction Industry Forecast: The State of the Minnesota Economy Wednesday, October 17, 2018

Presented by: Ron Wirtz (Federal Reserve Bank of Minneapolis)

During this program, Ron Wirtz from the Federal Reserve Bank of Minneapolis will offer a short primer on the Federal Reserve System and the Federal Reserve Bank of Minneapolis, and its role in the economy. Part of Ron's work includes extensive outreach to business and community leaders, and he gives frequent speeches on Ninth District regional economies.
