Tell the MCA about your family:

STAHL CONSTRUCTION will

preserve the legacy of St. Paul's architecture by restoring historic company signs that distinguish the Lowertown neighborhood, thanks to a new \$45,000 grant from the John S. and James L. Knight Foundation. Stahl Construction was one of 42 winners, and the only for-profit company, in the Knight Arts Challenge, a communitywide contest to engage and enrich the community through the arts.

Approximately two dozen signs were painted on the brick walls of commercial buildings in Lowertown by professionals commonly called "wall dogs" from the 19th to mid-20th centuries. These signs advertised a wide range of services and products from a cigar factory to carriages and stocks. Stahl Construction will select a number of these historic signs for restoration and conservation.

"We at Stahl are honored to receive this grant and could not be more energized to help rehabilitate and conserve a portion of St. Paul's historical legacy," said Thomas Surprenant, Stahl Construction's General Counsel. "At Stahl we've always felt that the buildings we construct are our legacy, but the Knight Foundation grant gives us a new and exciting way to contribute to the community."

"Vibrant cities find ways to preserve their history and tell their own stories," said Dennis Scholl, vice president of arts for Knight Foundation. "We're excited that Stahl Construction will be contributing to the community in this way."

Over the next three years, Knight Foundation will dedicate \$4.5 million to grant recipients of the Knight Arts Challenge in St. Paul. St. Paul is the fourth city to launch the Knight Arts Challenge, following Miami, Detroit and Philadelphia. ◆

STAHL CONSTRUCTION recently

completed construction of a new stateof-the-art emergency communications facility for Hennepin County. The 59,000-square-foot building will handle emergency calls, radio dispatch, and technical services for 37 communities, 23 law enforcement agencies and 21 fire departments in the region.

Located on Shenandoah Lane in Plymouth, Minnesota, this new building will replace the outdated and smaller emergency communications facility in Golden Valley. The facility features 21 dispatch consoles, a 7,000-square-foot data center, and a 9,500-square-foot garage for servicing communications equipment in emergency vehicles.

"This was an exciting and rewarding project for Stahl Construction due to the important role the facility will play in public safety for the surrounding communities," said Jessie Houlihan Bingen, Stahl Construction's President. "This project is a success due in large part to the coordination and teamwork that took place with project stakeholders including the Hennepin County emergency service department leaders and City of Plymouth officials."

The building incorporates sustainable Buildings, Benchmarks & Beyond (B3) Guideline elements. 76% of the construction waste generated during the 430 days of construction was diverted for reuse or recycling.

Stahl Construction worked alongside Wold Architects and Engineers (St. Paul) to complete this project. A ceremonial ribbon cutting and grand opening ceremony took place October 3rd at the facility. ◆

Ebenezer Tower Apartments, located at 2523 Portland Ave. S. in Minneapolis, is about to begin a major renovation of the 40-year-old building.



KRAUS-ANDERSON will be the general contractor of the extensive \$10.2 million project, which will maintain the integrity of the original design, while addressing needed upgrades to the 23-story senior high-rise.

Designed by Blumentals/Architecture Inc., major improvements to the 192-unit building will include new handicapped apartments, installing energy-efficient windows, remodeling the common areas, modernizing elevators, installing a fire protection sprinkler system and adding air conditioning in all apartments.

The exterior of the building will feature a new weather barrier finish. Other improvements will include new carpeting, cabinets and upgraded finishes.

"Affordable housing options for older adults continue to pose a challenge in the Twin Cities and throughout the country," said Jon Lundberg, Ebenezer's vice president of operations. "Maintaining quality housing options for those with low incomes is an integral part of our work and a cornerstone of the Minneapolis campus. The improvements to this 40-year-old building will greatly enhance the lives of our residents."

Located in historic Midtown Minneapolis, Ebenezer Tower Apartments offers seniors independent living in a residential neighborhood with exceptional views of downtown. With homes for adults 62 and older, Ebenezer Tower has 101 market rate apartments and 91 apartments available as Department of Housing and Urban Development (HUD) Section 8 residences. Ebenezer Tower Apartments are affordable for residents who meet low, very low or extremely low income requirements as set by HUD. Under the Section 8 Rental Assistance Program, residents pay 30 percent of their adjusted income for rent.

The project will receive financing from the City of Minneapolis and through state and county sources, including Home Funds through Minnesota Housing Finance Agency.

A ceremony to mark the beginning of construction will take place at 2:00 p.m., Thursday, Oct. 30 at Ebenezer Tower Apartments. Construction is expected to be completed Dec. 2015. ◆

STAHL CONSTRUCTION recently completed construction of a new 40,000-square-foot accredited Roman Catholic elementary school in Maple Grove, Minnesota for Ave Maria Academy. The new school features 14 classrooms for pre-K through eighth grade, music choir room, dining hall, gymnasium, two-story open commons area with library and media center, and chapel with sloped auditorium seating.

With an estimated current enrollment of 215 students, the school was designed and built for future expansion. A projected second phase addition will create space for up to 500 students in total.

Completed during an 11-month construction schedule, Stahl Construction partnered with the project committee and subcontractors to make sure the project progressed and was completed on time despite the unexpected early autumn freeze and harsh winter conditions.

"We are pleased to have been a part of this exciting project," said John Petersen, Stahl Construction's Project Manager. "After renting space for the past 17-years, it was rewarding to present the students, staff and faculty of Ave Maria Academy with a wonderful new space of their own where the student body can learn and grow for many years to come."

Stahl Construction worked alongsideWold Architects and Engineers(St. Paul) in a design-build delivery method. ◆

Guardian Angels is a comprehensive senior care organization serving seniors in the northwestern corner of the Twin Cities that serves more than 2,500 senior Minnesotans each year,. Engel



Haus is the first continuum care senior housing community in Albertville.

Owned by Guardian Angels Senior Services of Elk River, Minn., Engel Haus will provide catered living services in apartment homes, assisted living and memory care, housed in a Bavarianthemed community that complements the region's history and culture. Up to 65 new employees will be hired at Engel Haus when it is fully opened and occupied. The site accommodates a later phase that could approximately double the square footage of the 15-acre campus.

KA has worked on multiple projects for Guardian Angels, including Angel Ridge, a 53-unit HUD building (1993); Guardian Angels Care Center, 42-bed addition (2007); Guardian Angels By the Lake, assisted living and two memory care suites (2011); Guardian Angels' corporate office remodel (2012).

Designed by Pope Architects, Engel Haus was developed by Kraus-Anderson Realty, which coordinated the development process with the City of Albertville. Engel Haus is the fourth senior housing project development in as many years for Kraus-Anderson Realty, which leases and manages more than four million square feet of commercial property, including office, industrial and retail shopping centers.

Located at the northeast corner of Radio Drive and Hudson Road, the master-planned development carefully weaves a mix of uses with pedestrianfriendly streetscapes. With Class A office space, shopping, restaurants and a hotel, CityPlace offers a unique mixeduse campus that caters to employers who value easy accessibility, walkability and a balance of work-life integration.

Redevelopment of the 100-acre project is well underway with anticipated construction delivery of the first phase of retail set for the summer of 2015. \blacklozenge
