





## Kraus-Anderson Construction

The Larking – Minneapolis, MN



Kraus-Anderson (KA) has completed construction of The Larking, a new \$100 million, 16-story residential tower and Wells Fargo branch, located at 615 S. 8th St. in the heart of the Minneapolis East Town district. Designed by ESG Architects, The Larking is a mixed-use development featuring a 400,714-square-foot residential complex that will deliver 341 market-rate apartments. The development includes three levels of underground parking and is anchored by a Wells Fargo branch and an additional 9,100 square feet of street retail space. The Larking's elegant Elliot Park residences cater to active urban professionals with over 30 floorplans including seven unique penthouses. The property offers artful elements including floor-to-ceiling windows, wide plank flooring, granite countertops, and exposed concrete ceilings and columns. Live-Work-Play amenities include a Sky Lounge, pool deck, fitness and wellness center, sauna, golf simulator, pet spa, work from home suites, conference room and a creation studio.

### HOW SOUND IS YOUR OFFICE?

You're finally back to working in your office after a long hiatus due to the pandemic, and you're noticing several facets of the environment that you hadn't noticed before. The primary complaint from people moving from their home office back to their employer's office is the lack of privacy. Acoustical challenges are the primary culprit in creating discomfort in the workplace.

### **OFFICE CONSIDERATIONS**

We filter two million bits of sense data every moment, all of us in different ways. For more auditory people, the modern office can be challenging. Design intention is to encourage collaboration, communication and serendipitous work encounters, with many benefits including improved access to natural light and ventilation..A by-product of these 'interactive' surroundings is that of noise. In the world's largest measurement of workplace effectiveness, just 30% of office occupants are happy with the noise levels in their workplace, and psychological studies often cite the role that 'irrelevant noise' plays in both disrupting work, increasing levels of stress and decreasing job satisfaction.

## ACOUSTIC SOLUTIONS MAKE A DIFFERENCE

With the trend toward open spaces with hard surfaces becoming more prevalent, it is critical to have proper acoustical design components now more than ever. Acousticians have proven that a proper Noise Reduction Coefficient (NRC) should be between .80-1.0 NRC for Commercial Spaces, Board Rooms and Offices, Gathering Lounges, Cafeterias, Open Spaces and Lobbies. There are THREE WAYS to manipulate sound:


- 1. Absorption: 'Soaking Up' or removing sound to correct reverberation.
- 2. Reflection: 'Redirection' of sound to cause phase cancellation.
- 3. Diffusion: 'Uniformly Scattering' sound to create a passive surround sound.

### **ACOUSTICS IN THE WORKPLACE**

Using a variety of acoustical materials throughout the workplace can help create spaces that influence wellness and productivity. It's been proven that good acoustic design can address acoustic shortfalls by the use of materials which absorb excess noise to enhance communication between teams, reduce disturbance from unwanted speech, improve speech privacy for private phone calls and enable employees to focus better on complex, concentrated tasks. This all leads to over-all satisfaction for employees and management.

### **EXAMPLES**

Site-fabricated acoustic fabric wall and ceiling panels (https://novawall.com/) are an excellent source of sound absorption and may be installed in existing spaces with little disruption of day-to-day operations.





Soundproof fully assembled portable privacy pods are ideally suited for the open-office environment that is short on space for private calls and conversations (https://poppinpod.poppin.com/Om-Collection/).

### **SUMMARY**

Inadequate acoustics in the workplace can lead to fatigue, headaches, hearing damage and heightened emotions which can lead to absenteeism, staff turnovers and low productivity. The aim for office design is to create a variety of workspaces, breakout zones, coffee areas and meeting rooms with the right level of acoustic absorption where occupants can talk and work without having to raise their voice to be heard (or whisper quietly to avoid being indiscreet).
